### **1. Introduction**

#### **Mission Statement**

"Great Sankey Parish Council is committed to making our green spaces more beautiful, sustainable and inspiring places to be for the wellbeing of our residents and visitors."

This document contains details of the maintenance and management over a 5 year period of the landscape features and soft landscape treatments for Great Sankey Parish Councils Green Agenda.

The overall aim is to adopt a coherent, strategic and integrated approach to the management of the soft landscape components associated with GSPC sites and to ensure that the natural resources of wild flora and fauna are conserved and, wherever possible, enhanced.

This document will be used as a basis to inform any long term maintenance and management strategies for all land owned and managed by Great Sankey Parish Council, in conjunction with the council's biodiversity policy.

### 2. Green Agenda

Great Sankey Parish Council is committed to making its green spaces more beautiful, accessible, sustainable and inspiring places to be.

The council's green agenda started in 2017 with the development of Lingley Green. The landscaping project was undertaken in response to concerns about vehicle speeds and had dual aims of traffic calming through the introduction of planting to provide screening and improving the overall visual amenity of the traffic island. The scheme has been a huge success and has inadvertantly changed how the area is used by local residents.

Vicarage Community Park gardens were opened 2020 on the tail end of the Covid pandemic. The joint project between Warrington Borough Council and the Parish Council has turned a previously waterlogged space into a beautiful park area for residents of all ages to enjoy.

The council recognises that open, green spaces are more important than ever to residents and has pledged to do more, giving residents welcoming spaces that are healthy, safe & secure, well-maintained and clean, and enhance biodiversity.

Community involvement is a key factor in the development of GSPC green space and the council is keen to give residents a bigger say in how green spaces are developed and used for the benefit of all who use them.

### 3. Aims

To retain and improve the council's green spaces to

- Improve the health & mental wellbeing of residents by providing safe and accessible sites for exercise, recreation and socialising.
- Encourage play and social activities for children by creating exciting, healthy outdoor spaces.
- Promote and encourage community involvement.
- Conserve and enhance biodiversity across the parish.
- To manage GSPC sites and maintain to a high standard.
- Maximise the use of GSPC sites.
- Address issues such as speeding traffic through innovative landscaping.

### 6. Projects

#### All initiatives relating to grounds management for GSPC will embrace the specified objectives within this document.

#### Туре

- 1. Enhancement of GSPC sites. May include increasing or improving the soft or hard landscaping in current green spaces.
- 2. Community projects
  - Working with existing groups & organisations within community centres e.g. preschools, to help with their green initiatives.

- New community initiatives on GSPC sites, e.g. community garden, bulb planting, bat/bird boxes, Men's Sheds
- Helping residents' groups or organisations to improve their local area by facilitating the set-up of 'Friends of' groups, providing advice and information on green projects and considering small donation requests.
- 3. Partnership working with external bodies, e.g. Landtrust, WBC, Housing Associations, Mersey Forest, Environment Agency, Woodland Trust, Local Schools, Scout Association, North West Wildlife Trust, RSPB.

#### Considerations

Projects will impact GSPC in a variety of ways but should not detract from the council's main priority to maintain the council's green spaces to a high standard.

New projects will be assessed in terms of their cost and resource implications for staffing, equipment, funding (both set-up and ongoing costs) as well as their benefits to the community.

Ideas may be brought to the council's attention by residents, community groups, councillors or staff and will be considered by the appropriate committee. The Clerk and Head Gardener will be an integral part of any discussion of new projects to help the council determine the sustainability and practicality of any proposal.

## 7. Budgeting

Regular operating costs for grass cutting, pruning and general site maintenance are constantly monitored and considered in detail during the budget review process each year. Regular operating costs form the base level for ongoing grounds maintenance budgets to allow for upkeep and replacement of both soft and hard landscaping on the council's current sites.

An allowance for new projects and/or enhanced service provision will also be provided within each annual budget. Enhanced service, or new projects may include more frequent grass cuts, increasing the amount of soft landscaping on current sites or extending the number of sites managed.

When considering new projects, the additional cost to the council in terms of both time and resource (both short and long-term costs) will be assessed and fully considered along with the benefit of the project to both the council and the wider community. Projects will only be taken on if they can be achieved without negatively impacting the basic level of maintenance for GSPC sites and may involve engaging the community, partnership working or increasing GSPC staffing levels.

- 3. **Hood Lane Community Centre**, Hood Lane North, WA5 1ET (corner of Crosfileds Recreation Ground, access via Hood Lane North)
- 4. Hood Manor Community Centre, Raikes Close, Dorchester Road, WA5 1UH
- 5. Bewsey Barn Community Centre, Bewsey Farm Close, Old Hall Road, WA5 9PB

- 6. **Tim Parry Recreation Ground**, next to Tim Parry Community Centre Grassed recreation area with childrens play area and MUGA
- 7. **Lingley Green**, junction of Park Rd & Lingley Rd, nearest postcode WA5 3PG Landscaped traffic island
- 8. **Childs Wood Field**, Canons Rd adjacent to St James Church, WA5 1EU Grassed area surrounded by trees
- 9. **Parish Playing Field**, Lingley Green Avenue, adjacent to Sankey Hub, WA5 3AA Football pitches and public open space
- 10. Vicarage Community Park, Liverpool Rd/Parsonage Way, nearest postcode WA5 1RS Landscaped park area with childrens timber trail.
